



PUBLIC PARTNER OFFER AGREEMENT

KommoGEN Partner Program

This document constitutes a public offer in accordance with applicable international commercial practice.

1. General Provisions

This Public Partner Offer (the “**Offer**”) is issued by **Mikhail Trapeznikov**, operating under the brand **KommoGEN**, an official partner of **KOMMO (QSOFT LLC)**, Partner ID **28694931**, hereinafter referred to as the “**Licensor**”.

This Offer is addressed to any legal entity, individual entrepreneur, or natural person, hereinafter referred to as the “**Partner**”, and defines the terms of partnership cooperation.

Acceptance of this Offer constitutes the conclusion of a Partner Agreement on the terms set forth herein.

2. Acceptance of the Offer

Acceptance of this Offer (“**Acceptance**”) is deemed completed upon the Partner performing any of the following actions:

- transferring a client ID to KOMMO / KommoGEN;
- referring a client who pays for services, licenses, or widgets;
- making payment on behalf of a client;
- commencing actual cooperation with KommoGEN.

No additional signing is required.



3. Subject of the Agreement

3.1. The Partner attracts clients for:

- connection, renewal, and use of **KOMMO**;
- consulting, implementation, automation, and support services;
- sale and use of **KommoGEN** widgets and solutions.

3.2. The Licensor undertakes to pay the Partner a commission for clients attracted under the terms of this Offer.

4. Partner Commission

4.1. Commission for **KommoGEN widgets and solutions** — **up to 50%** of the paid amount.

4.2. Commission for **services and implementation works** — **up to 15%** of the paid amount.

4.3. The exact commission percentage may be determined individually by agreement of the parties for specific deals.

5. Settlement Procedure

5.1. Commission payments are made within **5 (five) business days** from the date the Licensor receives payment from the client.

5.2. Payment models:

- the client pays the Licensor, followed by commission payment to the Partner;
- the Partner pays on behalf of the client (subject to confirmation).



5.3. Settlement currency:

- **USD** — for KOMMO-related services and licenses;
 - **other currencies** — by prior agreement.

6. Obligations of the Parties

The Partner undertakes to:

- provide correct and valid client identification data;
- not mislead clients regarding services or pricing;
- comply with KOMMO partner rules.

The Licensor undertakes to:

- properly register referred deals;
 - ensure transparent accounting;
 - pay commissions in a timely manner.

7. Confidentiality

The Licensor, acting as an official KOMMO partner, undertakes to comply with confidentiality and non-disclosure requirements regarding client data and commercial information.

In case of a breach, the client or Partner may submit a claim to the central software provider **QSOFT LLC (KOMMO)**.

8. Term and Termination

8.1. This Offer enters into force upon Acceptance and is valid for **1 (one) year**.

8.2. The Offer is automatically renewed for subsequent one-year periods unless terminated by either party.
